1. Mayor's Report:

<u>Trustee Caprio</u>: On behalf of the Parade and Festival Committee: Only (8) days until Homer Fest begins next Thursday. We have an exciting line up of bands for the festival. Thursday is Fireworks night; Friday afternoon is Special Needs Day for Homer Township residents with special needs and their families; Saturday morning is the parade. Returning food vendors are Rubi Agave, Pelican Harry's, Smokin Z BBQ, Davidson's, Pizza Mia and Cool Creations. Trustee Neitzke-Troike: On behalf of the Parks and Recreation Committee: Work is wrapping up on Phase 1 of the Heritage Park project. Phase 1 will be substantially complete in the next week, weather permitting. The Village Board will be considering a proposal for a 319 Grant Area as part of the Heritage Park Project at tonight's meeting. This phase includes the construction of storm water wetlands, bioswales and rain gardens on the east portion of Heritage Park as part of a water quality improvement project for the Long Run Creek Watershed, funded in part through Section 319 funding from the Illinois Environmental Protection Agency. Work is expected to be substantially completed by September 30, 2018. The bid opening for the Active Core Area of Heritage Park will be held on June 28 with an anticipated award of contract at the July 11 Village Board Meeting. Finally, in celebration of National Parks and Recreation Month, the Parks and Recreation Committee is sponsoring "Chalk-it-up!" the Village's first sidewalk chalk art competition. The event will take place

on Saturday July 14 at Stonebridge Park. In addition to a judged sidewalk art competition among participants, there will be a number of "featured artists" on display. The event is free of charge. Please visit www.homerglenil.org to register. Space is limited, so register soon.

Mayor Yukich added that they met with IDOT officials and were given an update of the 159th Street Construction project and that they are still on schedule to complete the construction by the end of 2018.

H. PUBLIC COMMENT

- 1. Mike Byrne and Rich Golden, Homer Glen residents, came before the Board to lodge a complaint against the property owners located at 17525 S. Parker Road, stating that a business is operating at the property. Mr. Byrne stated he had spoken to Chief Building Official Baber, but feels that more needs to be done to rectify the situation. The surrounding properties are zoned Rural Residential. The property in question at one time received agricultural zoning, but the property has not been farmed in 25 years. The new property owners are running a landscaping business from the property. Additionally, they are re-grading the property which is causing flooding on the neighboring lots. The Mayor and the Board asked a few questions and additional information was gathered. The Staff will look into the matter and get back to them.
- 2. Lynn McGary, on behalf of the Homer Area Chamber of Commerce, updated the Board that the organization is currently the guest of Rubi Agave until they are able to secure new office space. The phone number and email address have not changed. She also mentioned that there is a new telephone scam happening in the area; residents are receiving calls from persons claiming to be friends with the Township Supervisor and the Township Assessor and requesting to set up a meeting with the property owners in person with the promise of being able to lower the property taxes of the homeowner. She wants residents to know that this is a scam and to report any calls to the proper authorities.
