NORTHERN WILL COUNTY WATER AGENCY UPDATE

On November 9, 2016 Will County Circuit Judge Ray Rossi issued an opinion in the Northern Will County Water Agency's Eminent Domain Suit (14 ED 33) of American Lake Water Company's Lake Michigan Water pipeline. The judge ruled in favor of the agency on the following counts brought forward by the water company:

- whether the statutory requirements for the “taking” of the pipeline were met;
- whether the agency had made a “good faith” offer to purchase the pipeline; and
- whether the “taking” of the pipeline was necessary according to statute.
